# Proof of Identity and Proof of Address Guide



# Why do we need to confirm your identity?

In order to ensure fair and consistent assessment in place and in order that we have mechanisms in place to safeguard against malpractice.

## When do we need to confirm your identity?

If we don't already have proof of your identity, we may require it on a number of occasions, including but not limited to:

- When you are about to register for a training event
- When you are about to take an assessment

## What can you use to confirm your identity?

There are a number of documents you can use to confirm your identity and address which are listed below. The name on your photo ID must match the name on your proof of address.

# Proof of Identity (Photo ID)

#### Documents we can accept

#### ✓ Passport ✓ Irish Driving Licence/Driving Permit (Full or Provisional) ✓ National ID Card (E.U.)

These documents must be current (i.e. unexpired) and any copy or image should have clearly legible:

Photo • Name • Date of Birth • Number • Expiry Date

#### Documents we cannot accept

- X Marriage, Birth or Baptismal certificate
- X Employer ID Card, including semi-state bodies
- Certificate of Registration (issued by Garda National Immigration Bureau)
- X Temporary Residency Card

X Garda Age Card

X Travel Visa

# Proof of Address

#### Original or electronic documents. E-statements must include logo of regulated institution

#### Dated within the last 6 months

- ✓ Household utility bill (eg: gas, electricity, refuse waste, home broadband, home phone)
- ✔ Financial institution statement from a regulated bank (bank statement or credit card statement)
- ✓ Naturalisation and Immigration Service Letter confirming legal status
- ✓ Property tax letter

#### Dated within the last 12 months

- ✔ Insurance certificate or renewal document (Home insurance/ Motor insurance / Health insurance)
- ✔ Revenue Commissioners documents (P45, tax credits, pin verification and Vehicle Registration/log book, excludes P60)
- ✔ Department of Social Welfare letters (letters relating to social welfare claim, benefit or pension)

#### Documents we cannot accept

- X Mobile phone bill
- X P60
- X Pay Slip

- X PPSN Letter
- X Public Services Card
  - X Letters entitled "c/o address"
- X Any document stamped "not to be used for ID purposes" or "not to be used for any other public service"

## **Please note** - you may **NOT** use the same document as both Proof of Identity and Proof of Address.

- Ensure your full name, address, statement date and account/reference number are all visible
